

## Reflections on 2011

### A Drug Court for the Hunter

The highlight of the year was the opening of the Hunter Drug Court on 7 March 2011. After a whirlwind of intense planning and development by the partner organisations, the court opened in a packed formal ceremony at the Toronto Court house, which will be the Drug Court's home in the Hunter.

The opening ceremony was attended by the Premier, the Hon Kristina Keneally, the Attorney General, the Hon John Hatzistergos, Mr Laurie Glanfield, Director General of the Department of Justice and Attorney General, together with a number of judges, magistrates, Local Members of Parliament, and many other distinguished guests.

Addressing the Court, the Attorney General said:

*“Today I would like to pay tribute to the trailblazers who worked passionately and tirelessly as the NSW Drug Court grew from a fledgling pilot to a program that is today being expanded to the Hunter region. The program required a significant shift in thinking, particularly for prosecutors and Legal Aid lawyers used to the combatant style of a traditional court hearing. The success of the Drug Court is a result of many different agencies working cooperatively towards a common goal to transform drug dependent offenders into drug-free law abiding citizens.*

*The program, which runs for a minimum of 12 months, simply wouldn't work if one agency chose to go it alone. It needs the support of the DPP and the Police, Legal Aid, Health and Justice Health, Corrective Services and the Department of Justice and Attorney General as well as the non-government agencies that provide residential rehabilitation services, counselling and health treatment.*

*The heightened level of cooperation between all the agencies means that participants have to face up to their problems – if they try to bluff their way through the program – or lapse into old habits – the Drug Court team will almost certainly find out. But many participants ultimately appreciate this scrutiny. They have often grown in loveless households, fending for themselves and developing a “me against the world” attitude. When they come to the Drug Court they realise that the team does care about their future and wants them to succeed.”*

The Hunter Drug Court will be able to take up to 80 participants at any one time, and will sit up to two days per week at Toronto. All partner agencies were ready to start work on the opening day. Eight potential participants were waiting in the cells for the formalities to conclude, so their application to take part in the program could be considered by the Court.

## **Intensive Judicial Supervision**

For the twelve months up to March 2011 the NSW Bureau of Crime Statistics and Research (BOCSAR) conducted a research trial into intensive judicial supervision. Participants were randomly allocated into either an intensive judicial supervision (IJS) group or a supervision as usual (SAU) group. The 70 offenders in the SAU group met with the Drug Court judge once a week during the first phase of treatment. The 66 offenders in the IJS group met with the Drug Court judge two times a week during the first phase of treatment.

Performance on the Drug Court program was assessed through the results of random urine tests designed to detect illicit drug use and through the number of sanctions for non-compliance with the program accrued by the two groups. The researchers found that participants in the IJS group *“were significantly less likely to return positive urinalysis tests and had a significantly greater number of episodes of abstinence than participants in the SAU group.”*

Commenting on the findings, the Director of the Bureau, Dr Don Weatherburn, said that they provided further evidence of the effectiveness of the NSW Drug Court in reducing drug-related crime. *“The NSW Drug Court is the benchmark against which all other offender rehabilitation programs in NSW should be assessed. The success of the Drug Court is due in no small measure to the Court’s ongoing commitment to research and development.”*<sup>1</sup>

## **Housing Accord**

Stable housing is a fundamental element in supporting a drug dependant person’s recovery, and subsequent success, on the Drug Court Program. On 18 February 2011 a two year *Shared Access Operating Agreement* was signed between the Drug Court and Housing NSW. The partnership commenced with the signing of the agreement by Senior Judge Dive and Mr. Ken Bone, General Manager of the Greater Western Sydney Housing Services Division.

The partnership will provide housing and support to clients with complex housing needs in order to assist them to sustain their tenancies. A series of meetings, presentations and interagency visits have taken place in the lead up to the signing of the Accord.

## **Practitioners Conference**

The Attorney General the Honourable Greg Smith SC MP opened the Drug Court of NSW’s Practitioners’ Conference on 2 December 2011. His Honour Judge Dive and the Drug Court team welcomed 120 guests including Judges, Magistrates from NSW and interstate, and interagency program partners from both Parramatta and Hunter Drug Courts.

Dr Eileen Baldry, Professor of Criminology, University of NSW, gave a presentation outlining Pathways to Prison for Mentally Ill Offenders. Professor Ian Hickie AM

from the Brain and Mind Research Institute spoke about the Development of the Brain and its related changes in cognitive function and social behaviour. Other speakers addressed the conference on the effects of Drug Use and Crime on the Aboriginal and Vietnamese communities as well as prison communities.

Craig Jones, Research Manager at the NSW Bureau of Crime Statistics and Research spoke about the recent findings from a trial of intensive judicial supervision on Drug Court outcomes. The research, conducted at the Parramatta Drug Court, involved intensively supervising a sample of Drug Court participants more closely, preliminary results of which are very encouraging.

Dr Peter Bowron, Senior Scientist at the Palms Toxicology addressed the conference regarding analysis of biological samples for Drug Court.

The conference brought together those committed to therapeutic jurisprudence to share information and expertise. This team based approach where all agencies co-ordinate and share information is the essence of the success of the Drug Court program.

### **International Online program for Drug Court judges**

International co-operation across the globe saw Canada, the United States of America, Australia and New Zealand provide an on-line program on Drug Courts for the judiciary. Senior Judge Dive and Dr Astrid Birgden, the Director of the Compulsory Drug Treatment Correctional Centre, were amongst the international faculty.

The objective of the program was for 32 participant magistrates and judges to share their practical experiences. Reading material was provided on a website, and participants posted answers and then participated in a discussion board.

### **Prime Minister's Award**

Senior Judge Dive received the Prime Minister's Award for Excellence and Outstanding Contribution to Drug and Alcohol Endeavours at the 2011 National Drug and Alcohol Awards. The National Drug and Alcohol Awards are held annually to celebrate achievements in preventing and reducing alcohol and other drug use and harm in Australia.
